******Memorandum of Understanding******

I understand that I can be successful only if I stay on pace and work on my iFlagler classes(es) every day. If I am behind pace at the end of the 14-day grace period, I will be dropped.

High school students will be permitted to leave campus only if they meet set requirements. Otherwise, they will take their courses in the on-campus lab.

I understand that students who are granted the off-campus privilege will lose this privilege and be required to report to the on-campus lab instead, if they do not maintain the correct pace and a passing grade.

I understand that it is an iFlagler teacher's job to contact students and their parents/guardians for monthly progress calls and I will make myself available for these. If a teacher is unable to contact me and leaves a message, I will return the call in a timely manner.

I understand that if I do not respond to a teacher's email or phone message withing 48 hours that I may be dropped.

I understand that iFlagler operates on the same calendar as the district schools. Students who enroll in an iFlagler class after the first week of the current school term, will be caught up by the end of the 14-day grace period or will be dropped.

I understand that the segment exam for each course my be proctored by a district employee.

I understand that I must pass the segment exam to earn credit for the course.
